Know All Men by These Presents:

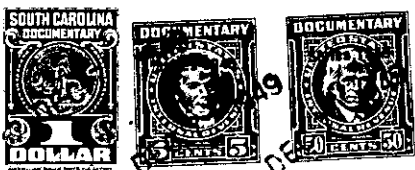
That I, Sara Ellen T. Chamblee in the State aforesaid, in consideration of the sum of One hundred fifty & no/100- - - - - DOLLARS,
