Know All Men by These Presents:

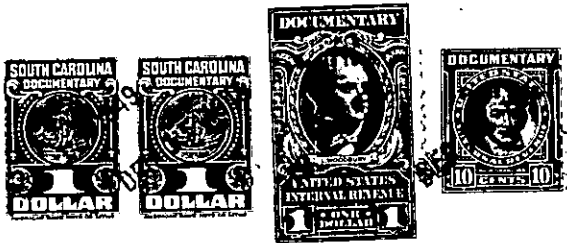
That we, Bernice O. Bowers and Mary T. Bowers in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. R. Cordell, his heirs and Assigns forever,

All that certain piece, parcel of lot of land, in Greenville Township, on the Western side of Long Hill Street, and being the Southern portion of lot No. 85, as shown on plat recorded in Plat Book M. at page 47, and being more particularly described by metes and bounds according to Plat made by Dalton & Neves June 29, 1947, as follows:

BEGINNING at an iron pin on the Western side of Long Hill Street at joint front corner of Lots Nos. 84 and 85, and running thence with the Western side of Long Hill Street, N. 7-10 W. 70 feet to iron pin; thence S. 89-47 W. 213.6 feet; thence S. 50-40 W. 58.8 feet to iron pin; thence S. 2-03 W. 33 feet to iron pin; corner of Lot No. 84; thence with the line of Lot No. 84, N. 89-47 E. 267.5 feet to the point of beginning.

Said premises being the Southern portion of the lot conveyed to the Grantors by Deed recorded in Book of Deeds 352 at Page 321.
