All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on West Washington Street in the City of Greenville, and being known and designated as Lot Number One (No. 1) on plat of the W. D. Workman property, recorded in the office of the R. M. C. for Greenville County in Plat Book "E" at page 293, and, according to said plat, having the following metes and bounds, courses and distances, to-wit:

BEGINNING at the southwest corner of Lots Nos. 1 and 2 on said plat, and running thence, S. 46-36 E. 21 feet to point; thence N. 42-30 E. 162.5 feet to point; thence N. 46-36 W. 21 feet to point; thence S. 42-30 W. 162.1 feet to the beginning corner.
