ELLIE FARNSWORTH R.M.C. Know All Men by These Presents:

That I, Irene B. Ducker in consideration of the sum of Five Hundred Fifty and No/100 (\$550.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Everett B. Willis, Jr., his heirs and assigns forever:

All that lot of land in Greenville Township, Greenville County, State of South Carolina, on the Eastern side of Irene Circle, near the City of Greenville, being shown as lot No. 37, on Plat of Royal Heights made by Dalton & Neves in April 1949, recorded in Plat Book W, at Page 25, and described as follows:

BEGINNING at a stake on the Eastern side of Irene Circle, at corner of lot No. 38, and running thence with the line of said lot, N. 85-21 E. 160.7 feet to a stake; thence N. 00-30 W. 70.2 feet to a stake at corner of lot No. 36; thence with the line of said lot, S. 85-21 W. 165.8 feet to a stake on Irene Circle; thence with the Eastern side of Irene Circle, S. 4-39 E. 70 feet to the beginning corner.

Subject, however, to the following restrictions:

- 1. Said lots shall be used for residential purposes only.
2. Said lots shall never be sold to, or occupied by, negroes, but this shall not apply to servants of the occupants and owners.
3. No trailer, shack, or temporary building of any kind shall be occupied as a residence, either temporarily or permanently.
4. No building shall be located on any residential building plot nearer than 30 feet to the front line, nor nearer than 10 feet to any side street; no building shall be located nearer than 5 feet to any side lot line.

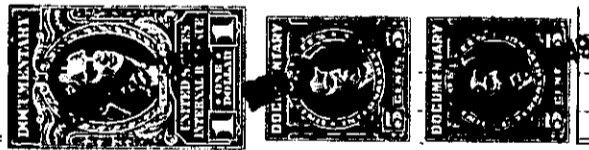
TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
