FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is PIEDMONT PLUSH MILLS, INC.

THIRD: That the principal place of business is

GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to manufacture ye plush and pile fabrics, and other cloths and textile fabrics from cotton, wool, silk, flax, hemp or other fibres or substances, or any mixture or combination thereof; to buy, sell or otherwise deal in any or all of said articles in the natural, raw or partly finished state; to dye, bleach, stamp, print or otherwise treat or finish its own products or the substances composing same, or the products of other manufacturers; and generally to conduct in allits branches a textile, milling and manufacturing business, and to do any and all things incidental to or necessary in the conduct of such business.
