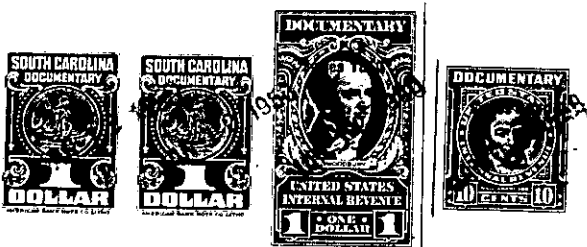
That We, W. F. Nabors and R. L. Bridges, in the State aforesaid,
