to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Alvin Y. Rosamond, Jr., his heirs and assigns forever:

All that lot of land in Greenville Township, Greenville County, State of South Carolina, on the Northeastern corner of the turn of Irene Circle, near the City of Greenville, being shown as lot No. 20 on Plat of Royal Heights, made by Dalton & Neves, in April 1949, recorded in Plat Book W, at Page 25, and described as follows:
