Know All Men by These Presents:

That I, ** Lizzie Griffith in the State aforesaid, in consideration of the sum of Ten dollars, and love and affection for my child, DOLEARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Willie V. Griffith, her heirs and assigns:-

That certain parcel or tract of land in Butler Township, said County and State, near Pelham, S.C., and lying on the north side of the Pelham Road, designated as tract No. 2 on plat of property of the grantor, by Dalton & Neves, Dec. 1949, and containing five (5) acres and having the following courses and distances to-wit:

Beginning at the joint corner of tracts 1 and 2 on the Pelham Road, and thence dividing said tracts, N 21-56 E sixteen hundred and twenty-eight and 1/10th (1628.1) feet to an iron pin on the DeCamp line, joint rear corner of 1 and 2; thence with the DeCamp line N 57-25 W one hundred fifty-three (153) feet to the corner of tract No. 3; thence dividing Nos. 2 and 3 tracts S 20-43 W sixteen hundred sixty and eight-tenths (1660.8) feet to an iron pin on the said road; thence therewith S 70-00 E one hundred fifteen (115) feet to the beginning corner; and bounded north and northeast by DeCamp; east and southeast by tract No. 1; south by said road, and west and northwest by tract No. 3; and being part of the lands conveyed by Andrew Griffith to the grantor by deed recorded in Book 83 at page 99.

However, reserving unto myself the occupancy, use, control, rents, profits and income of, from and to the said premises for and during the term of my natural life.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
