Know All Men by These Presents:

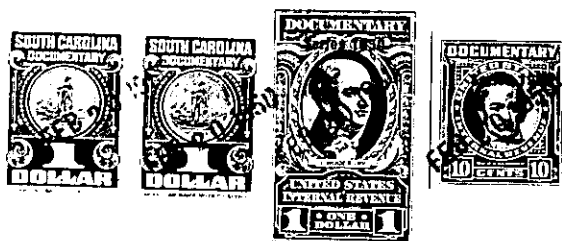
That I, Henry P. Willimon in consideration of the sum of Nine Hundred (\$900.00) in the State aforesaid, DOLLARS,
