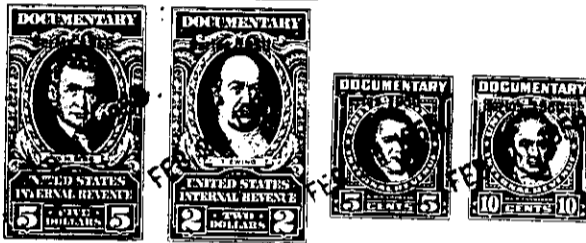
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John F. Smith, his heirs and assigns, forever:

All that piece, parcel or lot of land with the buildings and improvements thereon in Greenville Township, Greenville County, State of South Carolina, or the East side of Elizabeth Street in the subdivision known as North Hills, and being designated as Lot E as shown on a Plat of the said subdivision recorded in Plat Book "H" at page 90, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Elizabeth Street at a point 210 feet from Garraux Street; and thence running S. 65-17 E. 144.3 feet to an iron pin; thence N. 16-45 E. 50 feet to an iron pin at the rear corner of Lot D; thence along said Lot W. 65-17 W. 146.8 feet to an iron pin; thence along Elizabeth Street S. 13-12 W. 50 feet to the beginning corner.
