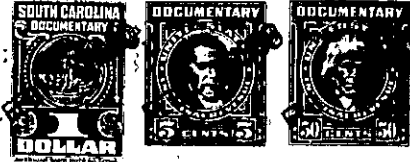

Cooper and his heirs and assigns: All of those parcels or lots of land situate and being in the County of Greenville, South Carolina, lying about one-half mile North from the Town of Simpsonville, in the Simpsonville School District, 2 lots lying on the Southwest side of and 3 lots lying on the Northeast side of the surface treated road that leads from Simpsonville to the Jonesville School, being all of lots 12, 13, 42, 43 and 44 on a plat of property made for S. T. Holland by J. A. Bruce, Surveyor, dated October 14, 1949, recorded in Plat Book W, at page 105, in the R.M. C. Office for Greenville County.
