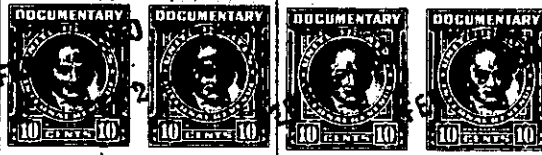

Know All Men by These Presents:

That Roy Waters and Eloise G. Waters in the State aforesaid, in consideration of the sum of Eighty Seven hundred and no/100 (\$8700.00) - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John R. McAdams, his heirs and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the North side of Pleasant Ridge Avenue in that area recently annexed to the City of Greenville, in Greenville County, S. C., being shown as Lot No. 36 on Plat of Property of Pleasant Valley, made by Dalton & Neves, Engineers, April 1946, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book P, pages 92-93 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Pleasant Ridge Avenue joint front corner of Lots 35 and 36 and running thence along the line of Lot 35 N. 0-08 W. 160 feet to an iron pin; thence S. 89-52 W. 60 feet to an iron pin; thence along the line of Lot 37 S. 0-08 E. 160 feet to an iron pin on the North side of Pleasant Ridge Avenue; thence along the North side of Pleasant Ridge Avenue N. 89-52 E. 60 feet to the beginning corner.

This is one of the lots conveyed to the Grantors by deed of Eston L. Rodgers, dated March 8, 1948, recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 338, page 475.
