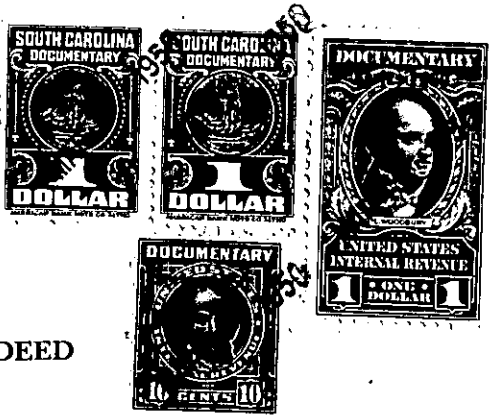

DEED
