Know All Men by These Presents:

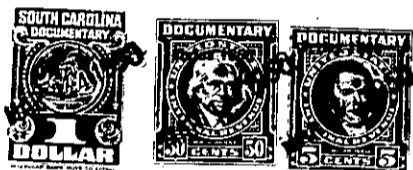

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Addie A. Vaughan, her heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the South side of the road leading from Mauldin to Conestee near the Town of Mauldin, in Austin Township, Greenville County, South Carolina, being shown as Lot 3 on plat of Property of E. M. Bishop and Rosa Lee Bishop made by W. J. Riddle, Surveyor, August 1948, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book S, page 127, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of the road leading from Mauldin to Conestee at joint front corner of Lots 2 and 3, and running thence along the line of Lot 2, S. 5-10 W. 200 feet to an iron pin; thence N. 76-40 W. 100 feet to an iron pin; thence with the line of Lot 4, N. 5-10 E. 200 feet to an iron pin on the South side of road leading from Mauldin to Conestee; thence along the South side of said road, S. 76-40 E. 100 feet to the beginning corner.

The Grantee is to pay 1950 taxes.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
