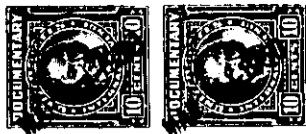

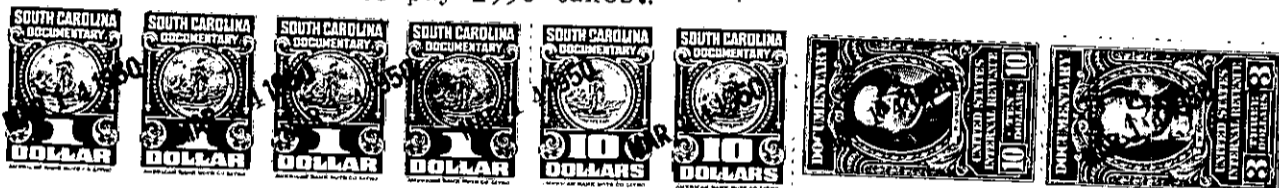

All that certain piece, parcel or lot of land situate, lying and being on the Northeast side of East Faris Road, in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot 81 on Plat of Forest Heights, made by Dalton & Neves, Engineers, June 1946, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "P", page 71, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of East Faris Road at joint front corner of Lots 80 and 81 and running thence N. 55-30 E. 177.8 feet to an iron pin on the Southwest edge of an alley; thence along said alley N. 47-44 W. 68 feet to an iron pin; thence along the line of Lot 82 S. 67-20 W. 151.2 feet to an iron pin on the Northeast side of East Faris Road; thence along East Faris Road S. 25-57 E. 50 feet to an iron pin; thence continuing along East Faris Road S. 27-55 E. 50 feet to the beginning corner.
