AGREEMENT

WHEREAS, the undersigned ^{LILLIE FARNSWORTH} property owners on Hampton Avenue and Pinckney Street in the City of Greenville purchased lots which were originally a part of the Bryan Estate as shown by plat recorded in R. M. C. Office for said County and State in Deed Book HHH, Page 838, and all of said lots were described by metes and bounds as shown on said plat, and show that they abutted on an alley running parallel with Hampton Avenue and Pinckney Street. However said alley has never been taken over by the City of Greenville and is not a public alley, and

WHEREAS in recent years said alley has become impassible, having grown up in weeds, etc, and is not used,

NOW, THEREFORE, we, the owners of Lots Nos. 4, 5, 6 and 7, fronting on Hampton Avenue, and Lot No. 11, fronting on Pinckney Street, and the Pinckney Street School, which takes up all of the original lots Nos. 8, 9 and 10, desire to close said alley and declare it abandoned. We likewise agree that the abutting lot owners shall take over one-half of said alley under the general law. Said alley is shown to be 16 1/2 feet wide at the Western end, and 23 feet wide on the eastern end.

NOW, THEREFORE, in consideration of the mutual benefits to be derived by the respective lot owners, we hereby agree to close said alley and declare it abandoned, with each of us taking our respective half of the alley to the center line. This agreement will not affect the rights of any land owner to the alley running by the side of Lot No. 11, on Pinckney Street and to the owner of Lot No. 3 on Hampton Street to have access to the alley running South from Pinckney Street.
