to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), has (have) granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ALVIN LEE BABB

A portion of that piece, parcel or lot of land in Click Springs Township, as shown on survey of the property of J. P. Rosamond, dated April 27, 1945, by Pickell & Pickell, Engineers, and having according to said survey the following metes and bounds, to-wit:

BEGINNING at a point on county road, at corner of property, this day conveyed by J. N. Helton to the grantee herein and running thence along said road N. 51 E. 45 feet to a point; thence S. 37-30 E. 126 feet more or less to a point; thence S. 45-45 W. 45 feet to a point in line of property this day conveyed by J. N. Helton to the grantee herein; thence along Helton's line (formerly) N. 37-30 W. 198 feet more or less to the point of beginning.

The county road herein referred to is sometimes called the Batson road.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
