Know All Men by These Presents:

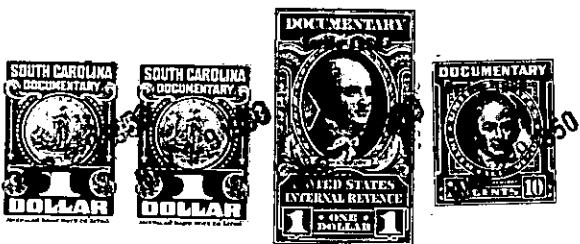

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), has(have) granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. W. Cannon, herein called grantee, all that lot in the City of Greenville, shown as a part of Highland Terrace, Hindman Development, addition to Greenville, S. C., dated October 1936, and recorded in Plat Book K at Pages 120-122, and is shown as Lot 7 of Block H fronting on Townes Street Extension. From this plat the following description is taken:

BEGINNING at a point on the western edge of Townes St. Extension which point is the joint front corner of Lots 6 and 7, and running thence their joint line N. 73-16 W. 150' to their joint rear corner; thence S. 16-44 W. 50' to the joint rear corner between Lots 7 and 8; thence their joint line S. 73-16 E. 150' to their joint front corner on the western edge of Townes St. Extension; thence running with the western edge of Townes St. Extension N. 10-44 E. 50' to the beginning corner.

This lot is also shown on County Tax maps as District 7 10, map 176, Block 3, Lot 15.

The grantee is to pay the 1950 taxes.
