NOW, Therefore, Know all Men by these Preesents, that I, E. INMAN, Master, in and for the County
of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$1000.00

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said Alice Glickman, Phillip Zaglin, Lewis Zaglin, Marion Zaglin and
Jack Zaglin, all the right, title and interest of the minor Plaintiff's,
Marsha Glickman and Harriet Glickman, the same being an undivided
1/42 interest each, in and to the following described property:

Lot # 1

All that certain piece, parcel or lot of land situate,
lying and being in the City and County of Greenville, State aforesaid
being on the West side of Townes Street and known as lot #25, on a
plat made by J. N. Southern, D. S., on Dec. 14, 1887; said plat re-
corded in R. M. C. Office for Greenville County in Deed Book "TT" at
page 649 and containing on-fourth acre, more or less, and being a part
of the De Camp property. Being the same property conveyed to C. Zaglin
by E. A. Gilfillin and L. B. Houston by deed dated April 7, 1919 and
recorded in the R. M. C. Office for Greenville County in Deed Book 44,
at page 542:
