Know All Men by These Presents:

That David W. Balentine in consideration of the sum of Seventy-eight Hundred Fifty and no/100 (\$7850.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said George H. White, his heirs and assigns:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the Northerly side of Ashley Avenue, in the City of Greenville, South Carolina, being shown as Lot No. 2 on the plat of B. H. Trammell made by Dalton & Neves and recorded in the RMC Office for Greenville County, S. C., in Plat Book "X", page 107, and having according to said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the Northerly side of Ashley Avenue at a point 1103.7 feet West of the North-west corner of the intersection of Ashley Avenue and Townes Street Extension, joint front corner of lots 1 and 2 and thence due North 190 feet to a stake; thence across the rear of said lot N 79-50 W 40.5 feet to an iron pin on the line with property now or formerly owned by Poe; thence along the joint line with the Poe property S 9-45 W 203 feet to an iron pin on the Northerly side of Ashley Avenue; thence along the Northerly side of Ashley Avenue N 87-25 E 72.4 feet to the point of beginning.

This is part of the property conveyed to the grantor herein as shown in Deeds 396, page 145, which conveyance states that this property is subject to a sewer easement granted by L. O. Patterson to Mrs. Maude Wilson Lamb on September 12, 1941, said easement recorded in Deeds 237, page 178. In a survey of this lot made by R. W. Dalton, Reg. LS on March 25, 1950 (Plat not recorded) it was ascertained that said easement does not apply to this lot, but applies to other lots east of this lot, there having been several adjoining lots owned by L. O. Patterson at the time said easement was granted. GRANTEE TO PAY 1950 TAXES.
