to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. L. Harbin, his heirs and assigns

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, about two miles northeast of Taylors, S. C., and lying on the southern side of a newly cut street or road, shown and designated as lots 32, 33, 34, 35, 36, 37, 38, 39, and 40 on a plat of the R. L. Wynn Estate, plat made by J. Q. Bruce March 18, 1950, said plat to be recorded in the RMC office for Greenville County, and having the following courses and distances, to wit:---

COMMENCING at a point on the southern side of said newly cut road or street and at the corner of lot 31 and running thence along said newly cut road or street S 51-20 E 308 feet to a stake; thence S 84-26 E 581 feet to a stake; thence S 5-34 W 256 feet to a stake; thence N 73-45 W 729.4 feet to a stake; thence N 51-20 W 260 feet to a stake; thence E 38-40 E 173.5 feet to the point of commencement.
