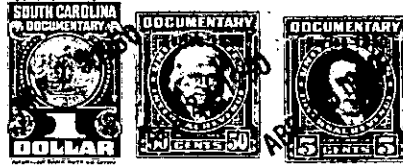

STONE, INDIVIDUALLY AND AS TRUSTEE in the State aforesaid, in consideration of the sum of FOUR HUNDRED- DOLLARS; to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J.G. LINDSEY, his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Western side of Brookwood Drive in a Subdivision known as Stone Estates, being known and designated as Lot No. 30, Block D of said Subdivision, and being described according to a plat of Stone Estates recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book G, at Page 292. The property herein conveyed has according to said plat the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the Western Side of Brookwood Drive at the joint front corner of Lots Nos. 29 and 30, and running thence along the common line of said Lots N. 78-38 W. 160 feet to an iron pin; thence N. 11-22 E. 25 feet to an iron pin, the joint rear corner of Lots Nos. 30 and 31; thence along the common line of Lots 30 and 31 S. 78-38 E. 160 feet to an iron pin on the Western side of Brookwood Drive; thence along the Western side of Brookwood Drive S. 11-22 W. 25 feet to an iron pin, the beginning corner.

The above described property is conveyed subject to the restrictive covenants applicable to Stone Estates recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Volume 298, at Page 149.

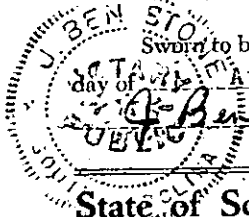
