

REASSIGNMENT OF LEASES

WHEREAS, R. R. STOKES and MADGE V. STOKES, by their assignment of leases dated October 11, 1949, recorded in Book 393, Page 319, Greenville County South Carolina, assigned to PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY, as additional security for one promissory note dated October 11, 1949, the rents, leases, profits and income from any part or parts of the following described land in the City of Greenville, Greenville County, South Carolina, to wit:

Stokes, et al, by deed dated May 14, 1946, and recorded in the R. M. C. Office of Greenville County, S. C., in Deed Vol. 291, at page 328.

WHEREAS, the said note has been paid in full and there is nothing due or owing on said certain note;

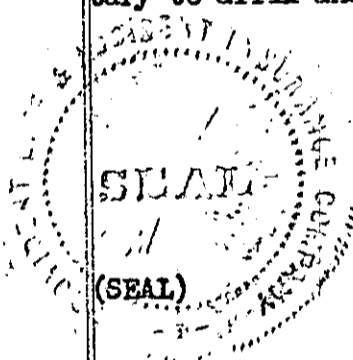

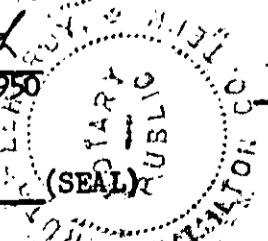
