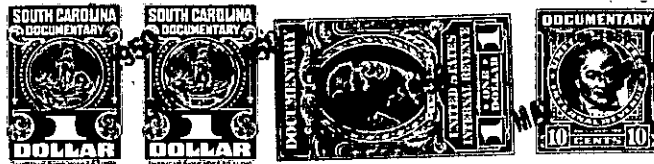
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. F. Cope and Azile C. Cope, their heirs and assigns, all that piece, parcel or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 79, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Bradley Boulevard at the joint front corner of Lot Nos. 79 and 80 and running thence with the joint line of said lots N 37-34 W. 166.4 feet to an iron pin on the southern side of Brookside Circle; thence with the southern side of Brookside Circle N 59-03 E. 75.5 feet to an iron pin, joint corner of Lot Nos. 78 and 79; thence with the joint line of said lots S. 37-34 E. 157.7 feet to an iron pin, joint corner of Lot Nos. 78 and 79, on Bradley Boulevard; thence with Bradley Boulevard S. 52-26 W. 75 feet to the point of beginning.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.
