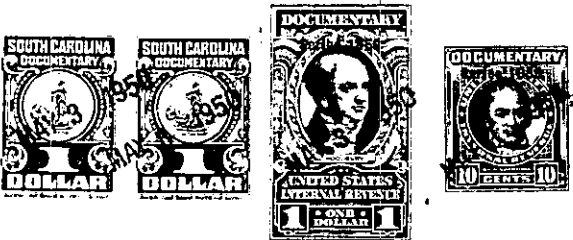
That We, Louise Earle and India E. Pepper in the State aforesaid,
