That I, Ollie Dykes in the State aforesaid, in consideration of the sum of Eight Hundred Twenty and 82/100 (\$820.82) and assumption of mortgage set out below DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do, grant, bargain, sell and release unto the said Herman W. Jones, his heirs and assigns forever:

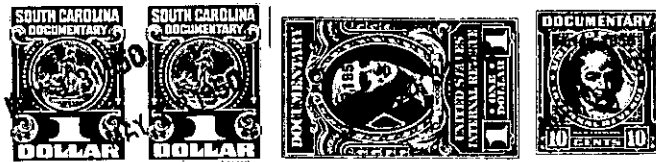
All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, on the Western side of King Street, known and designated as lot No. 33 on plat of the property of B. F. Martin in the subdivision known as West View, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book F at Page 140, and being more particularly described as follows:

BEGINNING at an iron pin on the Western side of King Street at the joint front corner of lots 32 and 33, and running thence in a Westerly direction with the line of lot No. 32, 143.8 feet to an iron pin; thence in a Northerly direction 50 feet to an iron pin, corner of lot No. 34; thence in an easterly direction 145.1 feet to an iron pin on King Street; thence with the Southern side of King Street in a Southerly direction, 50 feet to the point of beginning.

Being the same premises conveyed to the grantor by deed recorded in Volume 312 at Page 321.

Grantee is to pay 1950 taxes.

As a part of the consideration for this deed the grantee assumes and agrees to pay a balance of \$4838.18 due on a mortgage held by Fidelity Federal Savings & Loan Association recorded in Volume 363 at Page 268.
