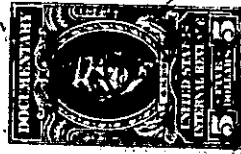

Know All Men by These Presents:

That I, S. R. Stover, in the State aforesaid,
in consideration of the sum of Eight Thousand Six Hundred and No/100 (\$8,600.00) ----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIAM P. GARRETT, his heirs and assigns, all that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, lying and being situate in the Southeast corner of the intersection of Pleasant Ridge Avenue with Panama Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot # 114, Pleasant Valley, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "P", at Page 93, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin in the Southeast corner of the intersection of Pleasant Ridge Avenue with Panama Avenue; thence along the Easterly side of Panama Avenue S. 4-11 W. 160.4 feet to an iron pin at the joint corner of Lots # 114 and # 183; thence N. 89-52 E. 62 feet to an iron pin at joint rear corner of Lots # 114 and # 115; thence N. 0-08 W. 160 feet to an iron pin at joint front corner of Lots # 114 and # 115 on the Southerly side of Pleasant Ridge Avenue; thence along said Avenue S. 89-52 W. 50 feet to an iron pin in the Southeast corner of the intersection of Pleasant Ridge Avenue with Panama Avenue, the point of beginning.

The herein-named grantee is to pay the 1950 taxes on the above-described property.

The above-described property is subject to restrictions recorded in the R.M.C. Office for Greenville County, South Carolina, in Deeds Volume 301, at Page 60, as amended in Volume 367, at Page 106.

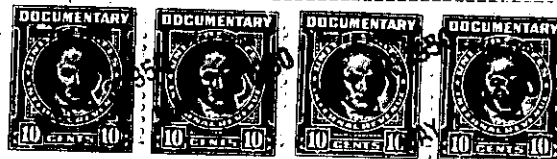
