

STATE OF SOUTH CAROLINA, GREENVILLE COUNTY.

Know All Men by These Presents:

That I, Edward Adair, herein called grantor in the State aforesaid, in consideration of the sum of One Dollar (\$1.00) and no/100, and love and affection DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), (s) (have) granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Nora Adair, herein called grantee, all that lot of land situated in the City of Greenville or immediately adjacent thereto, which is bounded and described as follows; the description being taken from Map of property of James Adair Estate located in Nicholstown, dated March 1948, made by W. J. Riddle, Surveyor, the map being at this time unrecorded;

BEGINNING at a point in the center of a street and running thence N. 16-31 W. 442.2' to a corner in the line of Cleveland Forest; thence with that line S. 64-44 W. 215.2' to a corner; thence along Balentine line S. 18-01 E. 417.3' to point in center of street; thence along this street N. 71-25 E. 201.1' to the beginning corner.

This being the same property conveyed to our deceased father James Adair by M. L. Ashmore, Delinquent Tax Collector, by deed dated February 3, 1938, and recorded in Book 202, at Page 31. The property is also shown on City Plat Book Map 66, Block 6, Lot 6.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(x) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(x) hereinabove named, and the grantee's(x) Heirs and Assigns against the grantor(x) and the grantor's(x) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
