KOON, in consideration of the sum of NINE HUNDRED AND NO/100 (\$900.00) in the State aforesaid, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto ~~the said~~ JAMIE ELMER TURNER, his heirs and assigns:

All that certain piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, on the Western side of Meridian Avenue, in a subdivision known as Super Highway Home Sites, being known and designated as Lot No. 136 of said subdivision, and being described according to a plat of Super Highway Home Sites, recorded in the RMC Office for Greenville County, in Plat Book P at page 53, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Meridian Avenue, at the joint front corner of Lots Nos. 135 and 136 and running thence along the common line of said lots N. 88-0 W. 182.5 feet to an iron pin in the center of a five-foot strip reserved for utilities; thence along the center of said five-foot strip S. 2-00 W. 95 feet to an iron pin, the joint rear corner of Lots Nos. 100 and 136; thence along the common line of Lots Nos. 100 and 136 S. 81-45 E. 183.6 feet to an iron pin on the Western side of Meridian Avenue; thence along the Western side of Meridian Avenue N. 2-00 E. 115 feet to an iron pin, the beginning corner.

The above described property is conveyed subject to restrictive covenants applicable to Super Highway Home Sites, recorded in the RMC Office for Greenville County in Deed Volume 291 at page 369. Said property is also conveyed subject to such easements and rights of way as may appear of record.
