to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. M. Paul, Jr. and E. M. Lineberger, Jr., their heirs and assigns, all that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 53, on plat of University Park by Walton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Bradley Boulevard at the joint front corner lot Nos. 52 and 53 and running thence with the joint line of said lots S37-34E 175 feet to an iron pin on the northern side of a twenty foot alley; thence with said alley N52-26E 75 feet to an iron pin, joint rear corner of lots Nos. 53 and 54; thence with joint line of said lots N37-34W 175 feet to an iron pin on the southern side of Bradley Boulevard; thence with Bradley Boulevard S52-26W 75 feet to the point of beginning.

This being a portion of the property conveyed to the grantors by deed recorded in the R.M.C. Office for Greenville County in Volume 345 at page 159.
