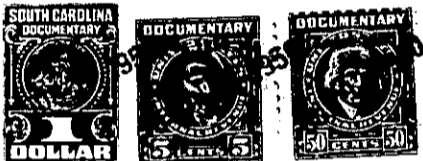

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Troy O. Tolliver, his heirs and assigns,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, on south side of Palmetto Street near the Cedar Lane Road, being known and designated as Lot Number Twenty Six (No. 26) in the subdivision of the G. J. Douglass lands, as shown by plat recorded in Plat Book "F" at page 126 in R. M. C. office and having the following metes and bounds, to-wit:

BEGINNING at a point on south side of Palmetto Street, joint front corner with Lot No. 27, and running thence S. 10-50 W. 141.3 feet along eastern line of Lot No. 27 to point, joint rear corner of Lots Nos. 14, 15, 26 and 27; thence S. 79-10 E. 70 feet along rear line of Lot No. 15 to point, joint rear corner of Lots Nos. 15, 16, 25 and 26; thence N. 10-50 E. 141.3 feet along western line of Lot No. 25 to point on south side of Palmetto Street; thence N. 79-10 W. 70 feet along south side of Palmetto Street to the point of beginning.
