

C., and on the south side of a county surfact treated road that leads in to the Rutherfordton woad, said lot being known and designated as number 6, as shown on a plat of the R. j. Wynn Estate made by J. Q. Bruce, March 18, 1950, said plat to be recorded in the RMC office of said County, to which plat reference is made for a description by courses and distances.
