

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMES E. RIDGEWAY, his heirs and assigns, all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying and being situate about three (3) miles from the Greenville County Court House, being known and designated as Lot # 33 of Sunset Hills, as shown on plat thereof made by R. E. Dalton, dated December 1945, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on Meyers Drive 75 feet from Waccamaw Avenue and running thence N. 41-10 W. along Meyers Drive 75 feet to an iron pin, corner of Lot # 34; thence S. 48-50 W. along the line of Lot # 34 175 feet to an iron pin, joint corner of Lots # 33, # 34, # 47 and # 48; thence S. 41-10 E. 75 feet to an iron pin, joint corner of Lots # 33, # 32, # 49 and # 48; thence N. 48-50 E. along the line of Lot # 32 175 feet to the beginning corner.

Said lot is subject to the restrictions or protective covenants contained in the instrument executed by Noland Meyers, dated March 6, 1946, recorded in the R.M.C. Office for Greenville County, South Carolina, in Deeds Volume 288, page 204, as fully and completely as though said restrictions or protective covenants were fully set forth in this deed.

The Grantee herein is to pay the 1950 taxes on the above-described property.
