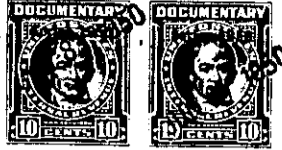

That William S. H. Piper by his attorney in fact, Ruth M. Piper, and Ruth M. in the State aforesaid, in consideration of the sum of One Thousand Six Hundred Ninety Five (\$1695.00) DOLLARS, R.M.C.

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ida Heatherly, her heirs and assigns, all that piece, parcel or lot of land in the State and County aforesaid, in the city of Greenville, being designated as Lot No. 9, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of U. S. Super Highway No. 29 at the joing front corner of lot Nos. 8 and 9 and running thence with the joint line of said lots N37-34W 180 feet to an iron pin on the southern side of a 20 foot alley; thence with said alley S52-26W 100 feet to an iron pin, joint rear corner of lot Nos. 9 and 10; thence with the joint line of said lots S37-34E 180 feet to an iron pin on the northern side of the right of way of U. S. Super Highway No. 29; thence along said Highway N52-26E 100 feet to the point of beginning.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.

This conveyance is subject to the Restrictive covenants recorded in Volume 325 at page 11 and as amended in Volume 343 at pages 7 and 256.
