to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Harley Moore and Viola B. Moore, their heirs and assigns,

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, about six miles south of Greenville Court House, east of the Augusta Road, being known and designated as Lot Number Eight (No. 8) on north side of Eastview Drive on plat and survey of subdivision known as "Clearview Heights", made by M. H. Woodward, R. E., December 1945 and recorded in the R. M. C. office for Greenville County in Plat Book "P" at page 1, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on north side of East-view Drive, joint front

corner of Lots Nos. 7 and 8, and running thence N. 18-04 W. 205.5 feet along the line of Lot No. 7, to point; thence N. 68-18 E. 86.4 feet to point, joint rear corner of Lots Nos. 8 and 9; thence S. 18-04 E. 211.2 feet along the line of Lot No. 9, to point on north side of Eastview Drive; thence S. 71-56 W. 86.2 feet to the point of beginning on north side of Eastview Drive.

This is a part of a tract of 18.91 acres, more or less, to Hicks by Willis and others by deed dated Nov. 3, 1944, recorded in Vol. 269 at page 179 in said R. M. C. office.

C. office, and this conveyance is subject to any and all restrictions as are set forth in said deed; also, subject to right of way reserved for sidewalk and power line, across the front of said lot.
