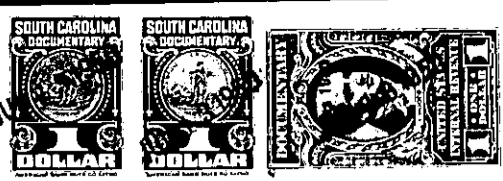

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, and being on the western side of Meridian Avenue in a subdivision known as Super Highway Home Sites, being known and designated as Lot No. 127 of said subdivision and being described according to a plat prepared by Dalton & Neves, Engineers, dated May, 1946, entitled "Map of Super Highway Home Sites near Greenville, S. C.", and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "p", Page 53, and having the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the western side of Meridian Avenue at the joint front corner of Lots Nos. 126 and 127 and running thence along the line of Lot No. 126, N. 88-0 W. 182.5 feet to an iron pin in the center of a five foot strip reserved for utilities; thence along the center of said five foot strip reserved for utilities, S. 2-00 W. 80 feet to an iron pin, the joint rear corner of Lots Nos. 127 and 128; thence along the line of Lot No. 128, S. 88-0 E. 182.5 feet to an iron pin on the western side of Meridian Avenue; thence along the western side of Meridian Avenue, N. 2-00 E. 80 feet to an iron pin at the point of beginning.

The above described property is conveyed subject to the restrictive covenants applicable to Super Highway Home Sites, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Volume 291, Page 369, and to such easements and rights-of-way as appear of record.
