That I, Claude I. Campbell in consideration of the sum of Seven Hundred (\$700.00) in the State aforesaid, DOLLARS.

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gertrude E. Herring,

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, state of South Carolina, near the city of Greenville, at the southeast corner of the interesection of Talley Street (formerly known as Pinckney Street) and "A" Street (sometimes known as Goldsmith Street) being a portion of lot No. 20 and 21 of the Hammett Estate as shown on plat made by W. A. Hudson May 14, 1900 and being more particularly described as follows:

Beginning at the southeast corner of Talley Street (formerly known as Pinckney Street) and "A" Street and running thence with the southeast side of said Talley Street in a southeasterly direction 140 feet more or less to the property of J. A. Hester; thence in a southwesterly direction along the line of the Hester property 60 feet to a point in line of Hester property; thence in a westerly direction 140 feet more or less to a point on the east side of "A" Street; thence with the east side of said street 60 feet to the beginning corner.

The depth of this lot may have been reduced from 140 feet due to "A" Street having been widened.
