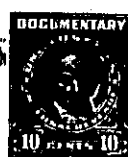

That T. C. STONE, HARRIET M. STONE, Individually and as Trustee/ in the State aforesaid, in consideration of the sum of ONE THOUSAND FIVE HUNDRED FIFTY (\$1,550.00) - - - - -

DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto ~~the said~~ AARON L. RUTLEDGE AND STELLA W. RUTLEDGE, their heirs and assigns, forever:

All that certain piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Eastern side of Broughton Drive, in a subdivision known as Croftstone Acres, being known and designated as the greater portion of Lot No. 41 and a small triangular portion of Lot No. 40, Block H, Croftstone Acres, a plat of the aforementioned subdivision being recorded in the RMC Office for Greenville County in Plat Book "S" at pages 78 and 79. The property herein conveyed is described according to a plat prepared by Dalton & Neves, Engineers, dated May, 1950, entitled "Revision of Block H, Lots 40-41-42 & Park, Croftstone Acres, Greenville, S. C.", and has, according to said plat, the following metes and bounds, courses and distances, to-wit:

BEGINNING at a point on the Eastern side of Broughton Drive, 45 feet in a North-westerly direction from the former joint front corner of Lots 41 and 42, and running thence N. 87-10 E. 104.5 feet to an iron pin; thence N. 63-47 E. 103 feet to an iron pin; thence N. 63-53 E. 95 feet to an iron pin; thence N. 7-32 W. 55 feet to an iron pin; thence N. 7-01 W. 15 feet to a point; thence S. 66-55 W. 168.6 feet to an iron pin; thence S. 87-10 W. 121.6 feet to a point on the Eastern side of Broughton Drive; thence along the Eastern side of Broughton Drive S. 2-50 E. 90 feet to the beginning corner.

Grantee agrees to pay taxes for the year 1950.

And the grantor(s) do hereby bind the grantor(s) and the grantor(s)'s Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee(s)'s Heirs and Assigns against the grantor(s) and the grantor(s)'s Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
