in consideration of the sum of Five Hundred and No/100-----(\$500.00)-----DOLLARS,

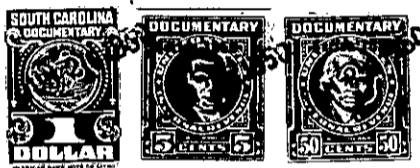

All that certain piece, parcel or lot of land, situate, lying and being on the Northwest side of Mayo Drive, in Gantt Township, in Greenville County, South Carolina, being shown as Lot #98, on Plat of Paramount Park, made by Piedmont Engineering Service, July 1949, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "W", at page 57, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Mayo Drive, at joint front corner of Lots 97 and 98, and running thence with the line of Lot 97, N 11-30 W 139 feet to an iron pin; thence N 73-35 E 91.2 feet to an iron pin on the west side of Crosby Circle; thence with Crosby Circle S 16-50 E 29.5 feet to an iron pin; thence continuing with Crosby Circle S 26-00 E 65 feet to an iron pin; thence still with the curve of Crosby Circle (the chord being S 19-00 W 35.4 feet) to an iron pin on the Northwest side of Mayo Drive; thence with the Northwest side of Mayo Drive S 64-00 W 95 feet to the beginning corner.
