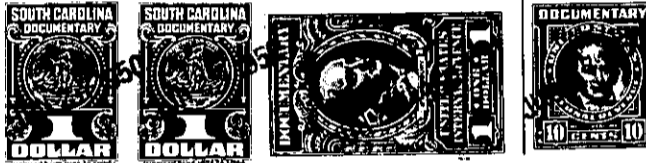

All that piece, parcel or tract of land in Paris Mountain Township, State of South Carolina, County of Greenville, formerly a part of the J. M. Nabors property, containing 3.7 acres, more or less, and having the following metes and bounds, to-wit:

Beginning at a point at the joint northwestern corner of the property of S. D. Addis and other property of the grantor herein, which point is on the line of the Fred Moody land and running thence S. 44 W. 3.31 chains along said Moody line to an iron pin; thence S. 29 E. 3.39 chains to an iron pin; thence S. 48 1/2 E. 6.70 chains to an iron pin at the joint corner of property of S. D. Addis and property formerly belonging to J. M. Nabors; thence N. 18-32 E. 5.43 chains to iron pin; thence N. 53 W. 5.75 chains to the beginning corner, and being a portion of 29 1/2 acre tract heretofore conveyed to S. D. Addis by J. H. and Annie Sue Bouchillon.
