All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 94, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

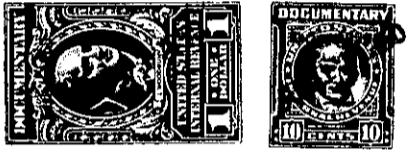
BEGINNING at an iron pin on the Northern side of Bradley Boulevard at the joint front corner of Lots. Nos. 94 and 95 and running thence with the joint line of said lots N37-34 W 182.5 feet to an iron pin, joint rear corners of Lot Nos. 94, 95, 119 and 120; thence with the joint line of Lot No. 120 N52-26 E 75 feet to an iron pin, joint rear corner lot Nos. 93, 94, 120 and 121; thence with joint line of Lot No. 93 S37-34 E 182.5 feet to an iron pin on Bradley Boulevard; thence with said Boulevard S52-26 W 75 feet to the point of beginning.
