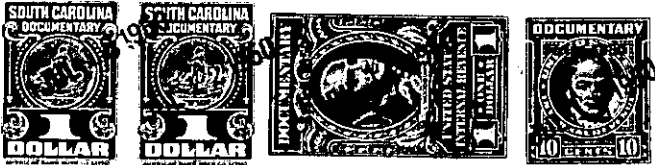

That We, Fred W. Owens and Mattie Lee E. Owens in consideration of the sum of Eight hundred sixteen and 75/100 (\$816.75) R.M.C. DOLLARS, and assumption of two mortgages set out below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Charles L. Center and his wife, Gwendolyn L. Center, All that certain piece, parcel or lot of land, situate, lying and being in Greenville Township, in the State and County aforesaid, lying on the South side of Summit Avenue, and being known and designated as a portion of Lot #15, of the property of Knox L. Haynsworth, Trustee, as shown on plat thereof made by Dalton & Neves, Surveyors, May 1941, and recorded in Plat Book "L" at page 177, and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the South side of Summit Avenue, joint front corner of lots #14 and 15, which pin is 457.2 feet west from the Southwest corner of the intersection of Worth Street and Summit Avenue, and running thence with the joint line of said lots, S. 34 W. 150 feet to an iron pin; thence S. 58-58 E. 50 feet to an iron pin; thence N. 34 E. 150 feet to an iron pin on the South side of Summit Avenue; thence along Summit Avenue N. 58-58 W. 50 feet to the beginning corner, and being the same land conveyed to us by Mrs. R.V. Potts, by her deed dated May 20th., 1950, and recorded in the R.M.C. Office for the County and State aforesaid, in Deed Book 410 at page 308.

As a part of the consideration for this Deed the Grantees assumes and agree to pay a balance of \$3250.25 due on a mortgage executed by Mrs. R.V. Potts to the First Federal Savings and Loan Association and \$1683.00 due on a mortgage executed by the Grantors to Mrs. R.V. Potts, and recorded in real-estate mortgage Book #462 at page 173 in the R.M.C. Office for the County and State aforesaid.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
