Know All Men by These Presents:

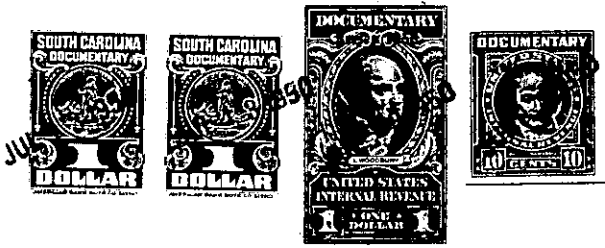

All that lot of land in Greenville County, State of South Carolina, on the Southern side of Prancer Avenue, in the City of Greenville, being shown as lot No. 309 on a plat of property of Pleasant Valley, recorded in Plat Book P at Page 92, in the R.M.C. Office for Greenville County and described as follows:

BEGINNING at a stake on the Southern side of Prancer Avenue, 480 feet East from Panama Avenue, at corner of lot No. 308, and running thence with the line of said lot, S. 0-08 E. 160 feet to a stake; thence N. 89-52 E. 60 feet to a stake at corner of lot No. 310; thence with the line of said lot, N. 0-08 W. 160 feet to a stake on Prancer Avenue; thence with the Southern side of Prancer Avenue, S. 89-52 W. 60 feet to the beginning corner.
