

BEGINNING at an iron pin at the intersection of Bradley Boulevard and Stephen Lane and running thence with the eastern side of Stephen Lane N 37-34 W 193.7 feet to an iron pin in creek; thence with the creek as the line, the traverse line of which is N 59-56 W 75.65 feet to an iron pin, joint rear corner of Lot Nos. 77 and 76; thence with the joint line of said lots S 37-34 E. 183.8 feet to an iron pin on the northern side of Bradley Boulevard; thence with Bradley Boulevard S 52-26 W 75 feet to the beginning corner.
