

All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, on the Northern side of Sycamore Drive near the City of Greenville, being shown as lots Nos. 57 and 58, on Plat of East Lynn made by Dalton & Neves in June, 1931, revised in February 1933, recorded in the R.M.C. Office for Greenville County in Plat Book H at Page 195, and described as follows:

BEGINNING at a stake on the Northern side of Sycamore Drive, 57.6 feet West from Boland Street at corner of lot No. 56, and running thence with the line of said lot, N. 9-14 W. 173.9 feet to a stake in line of lot No. 102; thence with the line of said lot, S. 81-02 W. 50 feet to a stake at corner of lot No. 59; thence with the line of said lot, S. 9-14 E. 156.8 feet to a stake on Sycamore Drive; thence with the Northern side of Sycamore Drive, S. 82-14 E. 26.1 feet to a stake; thence continuing with said Sycamore Drive, S. 78-09 E. 26.7 feet to the beginning corner.
