

All that certain piece, parcel or lot of land situate, lying and being on Rutledge Avenue, near the City of Greenville, in that section known as Sans Souci in Greenville County, South Carolina, being shown as lot 115 on plat of property of J. P. Rosamond, made by Dalton & Neves, Engineers, April 1931, and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book H at Page 185 and 186 according to deed of J. P.
