All those lots of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as lots Nos. 15, 16 and 17 of Block F, on plat of Buena Vista, recorded in Plat Book W at Pages 11 and 29, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Mayflower Street, corner of lot No. 14, and running thence with line of lot 14, S. 47-08 E. 150 feet to iron pin; thence S. 42-52 W. 116.7 feet to an iron pin on unnamed road; thence with said unnamed road, N. 47-08 W. 150 feet to an iron pin, corner of Mayflower Street; thence with the Southeastern side of Mayflower Street N. 42-52 E. 116.7 feet to the point of beginning.

Grantees are to pay 1950 taxes.



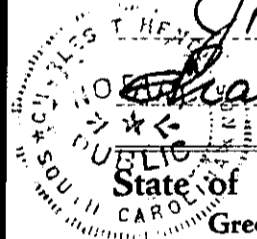

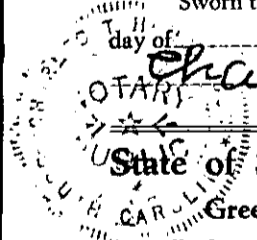

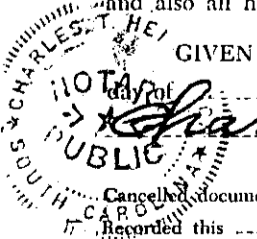
