Childers, Jr., his heirs and assigns forever,

All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 110, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R.M.C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

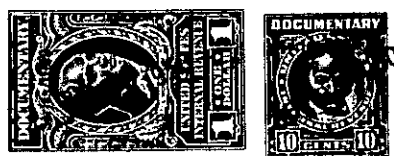
BEGINNING at an iron pin on the Southern side of Brookside Circle at the joint front corner of Lot Nos. 109 and 110 and running thence with the joint line of said lots S37-34 E. 182.5 feet to an iron pin at the joint rear corner of Lot Nos. 104, 105, 109 and 110; thence with the joint rear line of lot Nos. 104 and 110, N52-26 E. 75 feet to an iron pin; joint rear corner of Lot Nos. 111 and 112; thence with the joint line of said lots N37-34 W. 182.5 feet to an iron pin on the Eastern side of Brookside Circle; thence with the Eastern side of Brookside Circle S52-26 W. 75 feet to the point of beginning.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.
