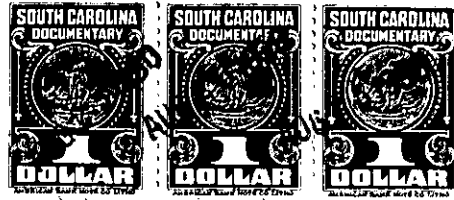

Verseal Caldwell and Daisy Ruth Caldwell all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known and designated as Lot No. 21, Block "B" of the subdivision known as Washington Heights, as shown by plat made by N. O. McDowell, Jr., and Julian D. Moore, Surveyors, December, 1944. Said plat being recorded in the R. M. C. Office for Greenville County in Plat Book "M" at page 107.
