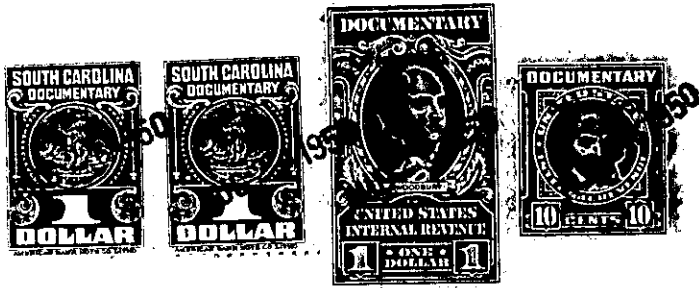

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these  
presents do grant, bargain, sell and release unto the said ... J.C. Alexander Jr. ....

all that piece, parcel or lot of land in Fairview Township, Greenville  
County, State of South Carolina , and containing Twenty Three and thirty four one-  
hundreth ( 23.34 ) acres, more or less, according to a survey made  
by E.E. Gary, Surveyor on November 9th 1946 and having the following  
metes and bounds to-wit ; - Beginning at an iron pin in Public Road  
said road running thru the old C. Rodgers, place, running thence  
S-54-E- 1.91 to a stone ; to a stone ; thence S- 51-1/2- E 4.80 to  
a stone; thence S-23-3/4- E - 11.00 to a stone ; thence S-51-1/4- E  
2.50 to a stone ; thence S-43-1/2- W - 8.23 to a Post Oak, thence  
S-85-1/4- W 7.40 to a stone ; thence N 5-1/4- E 19;00 to a stone ;  
thence N-86-1/2-W- 4.76 to an iron pin ; thence N-4-E- 3.58 to an
